PRIORITY LOTTERY REGISTRATION

This is for families who *CURRENTLY* have a child enrolled in our preschool.

We are looking forward to a wonderful 2026 – 2027 school year! Our first day of school will be on **Tuesday, September 1**. Attached is the Registration Packet for our Fall program.

Registration Packets for Priority Registration will be accepted from **Friday, February 13 through Wednesday, February 25 (3 PM).*****

When the registration packets are received, each packet will be assigned a number. The Preschool Board will conduct a random lottery draw to determine the order of class registration.

Children will be placed in classes according to the space available. The Board will try to accommodate any specific requests for teachers and/or class schedules. If top class choices are not available for enrollment, children will be placed on the highest available class choice and then placed on the waiting list for any choices that were not granted.

On **February 26 or 27**, you will get your child's class placement from his/her teacher.

***Families who missed the Priority Lottery Registration, but were eligible to participate, may turn in their registration packets and be included in the Open Enrollment Lottery.

OPEN ENROLLMENT LOTTERY REGISTRATION – Registration packets for families NOT currently enrolled in our preschool will be accepted beginning Friday, February 27 through Wednesday, March 11 (3 PM).

A lottery drawing for these packets will be done with the identical process as Priority Registration.

On **Friday, March 13**, we will notify families of their child's class placement.

After this date, remaining class spots will be filled on a first-come, first-served basis.

Registration Requirements for All Children

- ✓ **Registration Packet** completely filled out. Please be sure to include a **CURRENT PICTURE** of your child. (If you don't have one printed, you can email it to us.)
- ✓ **\$135.00 Fall Registration Fee** (Non-refundable). You can pay with Cash or Check. If you are also registering for Summer School, please write a separate check for that.
- ✓ **Up-To-Date and COMPLETE Immunization Record** needs to be turned in **unless** we already have a copy from this current school year. The immunizations required are: 3 Polio Doses, 4 DTaP, 1 MMR (given on or after the first birthday), 1 HIB (given on or after the first birthday), 3 Hep B, and 1 Varicella.
- ✓ **Physical** If we already have a Physical on file for your child, you do not need to submit a new form. If you are enrolling a new child, such as a sibling, please be sure to have your child's pediatrician fill out the Physical Form at the end of the Registration Packet. If you are not able to get an appointment before the registration deadline, hold on to the form and bring it to the Preschool Office as soon as possible. It can also be mailed or emailed.

* **September's Tuition** will be due on or before August 7, 2026 (Non-refundable).

Child Care Centers

See Title 22, Section 101223 of the California Code of Regulations for personal rights applicable to Child Care Centers.

- (a) Each child receiving services from a Child Care Center shall have rights which include the following:
- (1) To be accorded dignity in their personal relationships with staff and other persons.
 - (2) To be accorded safe, healthful and comfortable accommodations, furnishings and equipment to meet their needs.
 - (3) To be free from corporal or unusual punishment, infliction of pain, humiliation, intimidation, ridicule, coercion, threat, mental abuse, or other actions of a punitive nature, including but not limited to: interference with daily living functions, including eating, sleeping, or toileting; or withholding of shelter, clothing, medication or aids to physical functioning.
 - (4) To be informed, and to have their authorized representative informed, by the licensee of the law regarding complaints including, but not limited to, the address and telephone number of the complaint receiving unit of the licensing agency and of information regarding confidentiality.
 - (5) To be free to attend religious services or activities of their choice. Attendance at religious services, either in or outside the facility, shall be voluntary. In Child Care Centers, decisions concerning attendance at religious services shall be made by the child's authorized representative. To the extent that the child's authorized representative has agreed to the child's compulsory attendance at religious services and activities as a condition of admission in the admission agreement, a Child Care Center may require a child's attendance at such religious services and activities.
 - (6) Not to be locked in any room, building, or facility premises by day or night.
 - (7) Not to be placed in any restraining device, except a supportive restraint approved in advance by the licensing agency.

CHILD CARE CENTER NOTIFICATION OF PARENTS' RIGHTS

PARENTS' RIGHTS

As a Parent/Authorized Representative, you have the right to:

1. Enter and inspect the child care center without advance notice whenever children are in care.
2. File a complaint against the licensee with the licensing office and review the licensee's public file kept by the licensing office.
3. Review, at the child care center, reports of licensing visits and substantiated complaints against the licensee made during the last three years.
4. Complain to the licensing office and inspect the child care center without discrimination or retaliation against you or your child.
5. Request in writing that a parent not be allowed to visit your child or take your child from the child care center, provided you have shown a certified copy of a court order.
6. Receive from the licensee the name, address and telephone number of the local licensing office.

7. Be informed by the licensee, upon request, of the name and type of association to the child care center for any adult who has been granted a criminal record exemption, and that the name of the person may also be obtained by contacting the local licensing office.
8. Receive, from the licensee, the Caregiver Background Check Process form.

NOTE: CALIFORNIA STATE LAW PROVIDES THAT THE LICENSEE MAY DENY ACCESS TO THE CHILD CARE CENTER TO A PARENT/AUTHORIZED REPRESENTATIVE IF THE BEHAVIOR OF THE PARENT/AUTHORIZED REPRESENTATIVE POSES A RISK TO CHILDREN IN CARE.

IMPORTANT INFORMATION FOR PARENTS

CAREGIVER BACKGROUND CHECK PROCESS CALIFORNIA DEPARTMENT OF SOCIAL SERVICES

The California Department of Social Services works to protect the safety of children in child care by licensing child care centers and family child care homes. Our highest priority is to be sure that children are in safe and healthy child care settings. California law requires a background check for any adult who owns, lives in, or works in a licensed child care home or center. Each of these adults must submit fingerprints so that a background check can be done to see if they have any history of crime. If we find that a person has been convicted of a crime other than a minor traffic violation or a marijuana-related offense covered by the marijuana reform legislation codified at Health and Safety Code sections 11361.5 and 11361.7, he/she cannot work or live in the licensed child care home or center unless approved by the Department. This approval is called an exemption.

A person convicted of a crime such as murder, rape, torture, kidnapping, crimes of sexual violence or molestation against children **cannot by law be given an exemption that would allow them to own, live in or work in** a licensed child care home or center. If the crime was a felony or a serious misdemeanor, the person must leave the facility while the request is being reviewed. If the crime is less serious, he/she may be allowed to remain in the licensed child care home or center while the exemption request is being reviewed.

How the Exemption Request is Reviewed

We request information from police departments, the FBI and the courts about the person's record. We consider the type of crime, how many crimes there were, how long ago the crime happened and whether the person has been honest in what they told us.

The person who needs the exemption must provide information about:

- The crime
- What they have done to change their life and obey the law
- Whether they are working, going to school, or receiving training
- Whether they have successfully completed a counseling or rehabilitation program

The person also gives us reference letters from people who aren't related to them who know about their history and their life now.

We look at all these things very carefully in making our decision on exemptions. By law this information cannot be shared with the public.

How to Obtain More Information

As a parent or authorized representative of a child in licensed child care, you have the right to ask the licensed child care home or center whether anyone working or living there has an exemption. If you request this information, and there is a person with an exemption, the child care home or center must tell you the person's name and how he or she is involved with the home or center and give you the name, address, and telephone number of the local licensing office. - * Have a family member or contacts with a history of confirmed or suspected TB.
- * Are in foreign-born families and from high-prevalence countries (Asia, Africa, Central and South America).
- * Live in out-of-home placements.
- * Have, or are suspected to have, HIV infection.
- * Live with an adult with HIV seropositivity.
- * Live with an adult who has been incarcerated in the last five years.
- * Live among, or are frequently exposed to, individuals who are homeless, migrant farm workers, users of street drugs, or residents in nursing homes.
- * Have abnormalities on chest X-ray suggestive of TB.
- * Have clinical evidence of TB.
